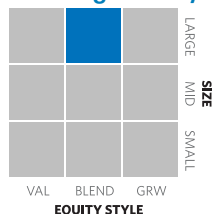

The Morningstar Style Box™ reveals a fund's investment style based on portfolio holdings.

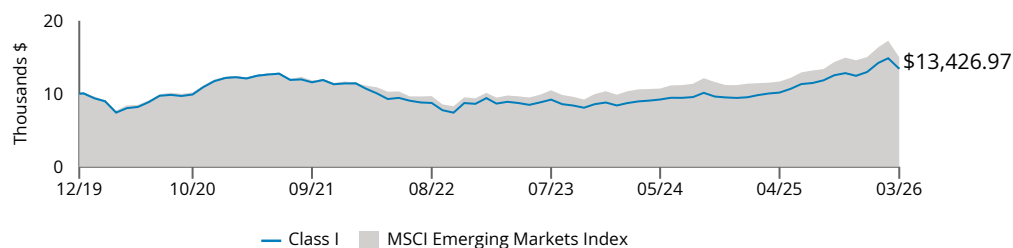
Why the fund?

There is no minimum investment for eligible plans investing in R6 shares.
