MACROECONOMIC OVERVIEW

U.S. equities finished the quarter higher, extending gains from the prior period. The dominant theme was a shift in Federal Reserve (Fed) expectations from a slower pace of cuts early on to increasingly dovish signals and broader forecasts for multiple cuts by year-end. However, by quarter's close uncertainty lingered over whether one or two additional cuts might come before December as Fed commentary offered no firm consensus. Overall, markets continued to trend upward, supported by strong economic data, robust earnings, and resilient consumer spending, alongside the anticipated start of a Fed easing cycle. Risks remain, however, including geopolitical tensions, softening labor data, elevated valuations, and ongoing tariff uncertainty, among others. Returns for the S&P 500® and high yield credit were positive for the quarter. The S&P 500® returned 8.1%, with Technology and Energy leading. Value underperformed growth for the quarter as the Russell 1000® Value Index returned 5.3% and the Russell 1000® Growth Index returned 10.5%. High yield credit underperformed the S&P 500® for the quarter. The Bloomberg U.S. Corporate High Yield Index returned 2.5%. Within high yield credit, intermediate duration credit underperformed longer duration. In addition, higher quality credit underperformed lower quality during the quarter. More specifically, the Bloomberg U.S. Corporate High Yield Long Index returned 8.7% versus 2.4% for the Intermediate Index. BA-rated bonds returned 2.3% while B-rated bonds returned 2.3% and CAA-rated bonds returned 4.4%. The ICE BofA Merrill Lynch Fixed Rate Preferred Index returned 4.4% for the quarter.

FUND OVERVIEW

Transamerica Multi-Asset Income overperformed the Transamerica Multi-Asset Income Blended Benchmark for the quarter (Total Return-Net). Within common equity during the quarter, the Financials and Telecommunications sectors contributed most to relative returns, both driven primarily by security selection. Technology, driven by an underweight allocation, and Real Estate, primarily due to security selection, were the largest detractors from relative returns during the quarter. On 9/30/2025, the portfolio allocation was 58.1% in common equity, 4.3% in preferred equity, 36.7% in corporate credit and the remainder in cash. The allocation to corporate credit was reduced in favor of common equity, reflecting the team's strategic shift to more attractive positions within the equity space. In credit, we continue to seek opportunities with attractive risk/return profiles. In our equity sleeve we remain focused on fundamental analysis.

OUTLOOK

During the quarter, the Federal Open Market Committee's (FOMC) September meeting resulted with a 25-basis point cut to the federal funds rate. Following the meeting, the market noted a shift in Fed rate cut forecasts from thoughts of a shallower rate path to the emergence of more dovish voices and broadening expectations for more cuts through year-end. However, by quarter's end there remained some uncertainty about whether 2025 could see one or two more rate cuts. Currently, TSW does not see a recession immediately taking place due to the strength of the U.S. consumer. As a result, we continue to monitor inflation, employment, and consumer spending as the Federal Reserve adjusts policy. TSW believes their ability to be nimble and flexible in this ever-changing market should allow them to take advantage of dislocations as they develop.
